PURPOSE:

To Providing self defense training to more and more Students and to develop the mind ,body, concentration, total personality of a Students /person and also Our aim is to produce champions players for our college and nation.

Both parties agree to the terms and conditions and Role & responsibilities as specified under:

1. Both the first party and the second party will continue to work together to teach self-defense karate to the students.
2. The first party will arrange the space to provide the training. Such as premises, halls, rooms, auditorium or any place where it would be suitable for students to learn karate and the other party will provide self-defence-karate training in Gossner College, Ranchi.
3. The Second Party will provide qualified male and female Karate Instructors for Self defence - Karate training.
4. The First party Initially provide one Tatami mat (65 pieces) for self defence - Karate practice and in the second phase the karate equipment will be provided which will be very important for the students.
5. The first party will provide one changing room for Instructors and Students.
6. The Second party will provide self defence training in the free time of the college and as directed by the First party. The Second party will provide karate training one day a week. It could be Sunday morning, evening or any other day. In future, the training timings can be changed with the consent of both the parties.
7. The second party will organize karate camp, karate championship, belt gradation test from time to time in which the first party will fully cooperate and support.

8. The Second party will charge a very reasonable and nominal monthly fee from the college student. The monthly fee will be increased from time to time with the consent of both parties.
9. The Second party will give 20% of the monthly fees received from college students to the first party as venue rent.
10. The first Party will provide Security and safety at the time of training .
11. The first party will fully cooperate with the first party in karate activities.
12. Both the first party and the second party together will organize self-defence karate training especially for girls and women.

GENERAL TERMS AND CONDITIONS

Any part of this MoU may be modified or changed by mutual agreement of both the parties hereto in writing. The modifications/changes shall be effective from the date on which they are modified/extended unless otherwise agreed to.

DISPUTE RESOLUTION

>All disagreements/differences of opinion/disputes regarding the interpretation of the provisions of this MoU shall be resolved by mutual consultation by the signatories.

>If the disputes are not mutually resolved, the same shall be referred to the sole Arbitrator appointed with mutual consent of all parties.

>The arbitration proceedings will be conducted and governed by relevant Indian laws.

>Both Parties irrevocably submit to the exclusive jurisdiction of the Courts in Ranchi for any action or dispute arising out of or in connection to this MoU
